IDEA's TPS Tournament in Beijing, China

November 9, 2006 - November 13, 2006

Join us for an amazing experience in historical culture and debate as we host a first-ever international university tournament from November 9th-13th at the Beijing Foreign Studies University in the heart of China's capital city. This tournament will feature motions related to the People Speak event and thus participants can earn IDEA guilders, which may be redeemed for prizes and waivers to IDEA events. In addition, Foreign Language Teaching and Research Press will give books as prizes to the winning teams.

The official format of the tournament will be a 4-team parliamentary debate in WUDC style. Training sessions for judges and debaters will also be available immediately before and after the tournament. In addition, qualified adjudicators will also be able to apply for IDEA accreditation upon successful completion of the training session. All training sessions will be conducted by IDEA's internationally accredited trainers.

Additionally, our tournament site offers students an opportunity to see the historic and modern sites of Beijing, from the Forbidden City and the Great Wall of China to Tiananmen Square. Tours and such can all be arranged.

Payment Details:

Tournament registration is free and will include an opening banquet and cultural closing ceremonies. However, participants are responsible for their own travel and lodging fees.

Lodging on campus in dorm rooms starts at \$12 per night and meals on campus are on average \$2.

Event Details:

The whole event will take place from November 9 to November 13. We will have training sessions for judges and debaters on November 9 and the morning of November 10. Five preliminary rounds start from the afternoon of November 10 and end at noon of the next day. On the afternoon of November 11, quarterfinals will be held. And on November 12, we will have semifinals and the grand final. The follow-up training is on November 13. Various cultural and sightseeing events will be organized during these days.

Brief introduction of the instructors for this tournament:

Sharon Porter received her Ph.D. from Louisiana State University in Baton Rouge, Louisiana, USA. After experience teaching on the junior high, high school and college level, Sharon was hired by Northern Arizona University (NAU) in 1981 to be the Director of Forensics (competitive speech and debate). She served in that position from 1981 to 1992 and again from 1999 to 2004, with a break from 1993-1999 during which she was the Director/Dean of the School of Communication. During the years Sharon served as the Director of Forensics NAU ran a nationally competitive team that gualified for and tournaments competed in national in policy, cross-examination, Lincoln-Douglas and Parliamentary Debate as well as eleven individual events. She was active in a number of professional forensic education organizations. Some of the positions she held included being a member of the Board of Trustees and a member of the National Council of the National Individual Events Tournament, chair of the Council of Forensic Organizations, Vice President of the American Forensic Association, President of Delta Sigma Rho-Tau Kappa Alpha and President of the National Parliamentary Debate Association. Sharon was active in tournament administration and worked in the tabulation rooms of the American Forensic Association-National Individual Events Tournament, the American Forensic Association-National Debate Tournament and the National Parliamentary Debate Association. Her contributions to the forensic community resulted in receiving a number awards including the Quintilian Award and two Distinguished Service Awards (from Delta Sigma Rho-Tau Kappa Alpha and the American Forensic Association-National Individual Events Tournament).

Shortly after retirement from NAU in 2004 Sharon was asked to become a consultant for the International Debate Education Association (IDEA). Her primary responsibility with IDEA has been to design and implement accreditation standards to ensure quality control of IDEA-NL member NGO's and International Trainers. She has attended the Youth Forums in Estonia, Macedonia and Romania as well as General Assembly and numerous organizational meetings in other locations. During the Romania Youth Forum she accepted the nomination to become a member of the Board of IDEA-NL, a

position she will hold until elections in Prague in November.

Rob Layne, Assistant Director of Forensics, Willamette University - Rob was an outstanding debater at Truman State University and a coach at Central Michigan University prior to coming to Willamette. This year he coached the Willamette Team to First Place in the National Tournament Sweepstakes Award as well as the Season Sweepstakes award. He was named as the American Forensic Association "Outstanding New Coach of the Year" for 2005-06. This award is given for a person in their first five years of coaching who is considered to be the outstanding coach in speech and debate.

莎伦•波特在美国路易斯安那州巴吞鲁日市路易斯安那州立大学获得博士学位。 莎伦曾在数所初中,高中及大学任教,1981年聘任为北亚利桑那大学(NAC) 演讲辩论赛领队。从1981到1992,1999到2004年莎伦担任该职,1993年至1998 年,她担任该校传媒学院院长。在莎伦任演讲辩论赛领队期间,NAC拥有一支 享誉全国的队伍,参加过政策辩论,交互讯问式辩论,林肯-道格拉斯式辩论, 议会制辩论,以及其他十一次个人比赛。她活跃于数个专业辩论教育组织,曾担 任过全国个人项目循环赛全国委员会成员,董事会成员,辩论组织委员会主席, 美国辩论协会副主席,全国议会制辩论主席。莎伦致力于循环赛管理,投身于美 国辩论协会,全国个人项目循环赛,美国辩论协会全国辩论循环赛,以及全国议 会制辩论协会的各项工作。因在辩论领域所作的贡献,莎伦曾多次获得嘉奖。 2004年莎伦从北亚利桑那大学退休后不久,应邀担任国际辩论教育协会(IDEA) 的顾问。主要负责制定并执行鉴定标准,确保 IDEA 成员非政府组织的工作质量 以及国际教练的专业水准。她曾参加过爱沙尼亚,马其顿及罗马尼亚的青年论坛, 还去各地参加过国际辩论教育协会的多次会议。在罗马尼亚青年论坛期间,她获
